**A**ustralian Venture Backed IPOs – 1992-93 to 2003-04 is the first definitive list of IPOs by the Australian private equity industry over the 12 year period from 1992 to 2004, and the first, comprehensive analysis of the share price performance of those IPOs.

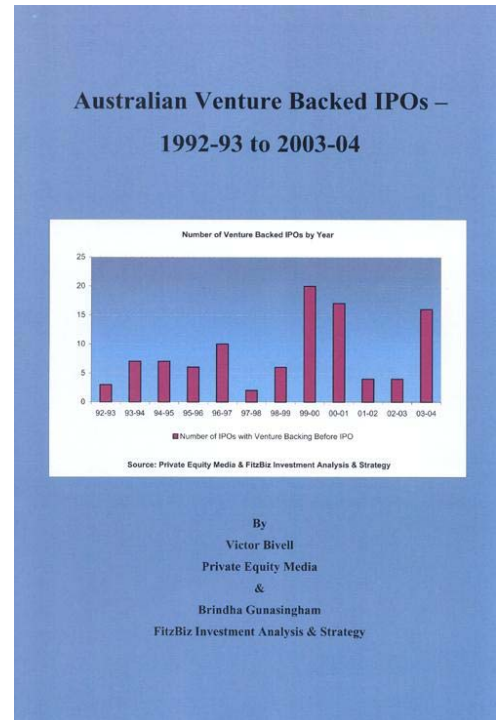
The report shows that there were 102 venture and private equity backed IPOs over the period and it lists and analyses these by year of listing, industry sector and venture capital backers as well as by alphabetical order.

The report shows that venture backed IPOs have outperformed the ASX All Ordinaries Index and the S&P/ ASX Small Ordinaries Index over one, three, five and ten year periods to 30 June 2004.

A wide range of share performance measures include annualized performance since end of first month and by full financial years of listing, compound annual growth rates over one, three, five and 10 years, and weighted average compound annual growth rates. Among others, there are also performance analyses by industry, market capitalisation, and comparisons with the ASX All Ordinaries Index and the S&P/ ASX Small Ordinaries Index.

The report also analyses attrition among venture backed IPOs, and other forms of venture backed IPOs including venture backing at IPOs, and overseas IPOs.

The 124 page A4 sized report contains 40 figures and charts, many quite extensive. It is available only in book format for \$495, which includes GST and postage.
